**Founders 3 closes \$98.0 Million Multi-Building Investment Sale at Woodland Prime in Menomonee Falls**

The Investment Brokerage division of Founders 3 has successfully closed the sale of two Class A properties located in Woodland Prime Corporate Park in Menomonee Falls. The buildings, located at W126N7353 and W126N7449 Flint Drive, are home to Leonardo DRS's Naval Power & Control Systems business line. The portfolio encompasses the recently completed 372,856 square foot ("SF") build-to-suit research and development ("R&D"), manufacturing, and testing facility as well as the adjacent 118,620 SF three-story office building, which serves as the corporate headquarters for the division.
