# NON-RESIDENTIAL CUSTOMERS

### STATE OF WISCONSIN BROKER DISCLOSURE



Wisconsin law requires all real estate licensees to give the following information about brokerage services to prospective customers.

- The duty to safeguard trust funds and other property held by the Firm or its Agents.
- The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

This disclosure is required by section 452.135 of the Wisconsin statutes and is for information only. # **Confidentiality Notice to Customers**
